Findings:

395 - TB Verification

General: Based on review of documentation, the surveyor found the following:

- (1.) Staff's (DOH: 9/6/11) file contained a copy of a negative tuberculin result that was read on 10/13/17; therefore, the tuberculin result is no longer current. Staff confirmed through interview that this is the most recent tuberculin result for the staff's file.
- (2.) Staff's (DOH: 10/21/19) file did not contain a statement from a health professional stating that the individual is free of active tuberculosis or a copy of a negative tuberculin result. Staff confirmed through interview that the documentation had not been obtained for the staff's file.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of documentation, and ECE - TRIS, the surveyor found the following:

- (1.) Staff (DOH: 9/1/18) obtained thirteen and one-half (13 1/2) of the required fifteen (15) hours of cabinet-approved early care and education training.
- (2.) Staff (DOH: 8/1/18) obtained seven and one-half (7 1/2) of the required fifteen (15) hours of cabinet-approved early care and education training.

During interview, staff confirmed that fifteen (15) hours of training were not obtained by the two (2) staff.
