General: Based on Review of Documentation, there was no current copy of the state regulations in the facility.

- (5) An individual described in subsection (4) of this section shall:
- (a) Submit to background checks described in paragraph (b) of this subsection;
- (b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:
- 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
- 2. Criminal records check required by KRS 199.896(19);
- 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
- 4. An address check of the Sex Offender Registry; and
- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, an employee with a hire date of 2/8/16 did not have results of an out of state background check in their personnel file. The staff person in charge stated that she had not noticed that she had listed another state on her CAN check. She was working in a classroom but was with another teacher.

Findings:

General: Based on Review of Documentation, there were two (2) staff with hire dates of 8/9/16 and 9/26/16 that did not have proof of education in their file.

325 - CPR/First Aid Coverage

General: Based on Observation, a staff person listed as a driver was not current in CPR/First Aid certification.

- (7) Except in accordance with subsection (8) of this section, the following shall be inaccessible to a child in care:
- (a) Toxic cleaning supplies, poisons, and insecticides;
- (b) Knives and sharp objects;
- (c) Matches, cigarettes, lighters, and flammable liquids;
- (d) Plastic bags;
- (e) Litter and rubbish;
- (f) Bar soap: and
- (g) Personal belongings and medications of staff.

Findings:

General: Based on Observation, a cabinet in the Infant Room was unlocked and contained a bottle of Ajax, window cleaner, disinfectant and air freshner. All of these items stated to keep out of reach of children. Additionally, a staff members purse was on the floor and was accessible to the children in the Infant Room. There was also an unlocked cabinet in the Three Year Old Room that contained air freshner and liquid detergent that was accessible to the children.

520 - Floors, Walls, Ceilings

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on Observation, there were multiple spots in the Three Year Old Room under the cubbies where the paint had peeled off of the wall. There were also spots of chipped paint on the walls in the boys' bathroom near the preschool room. Additionally, a tile was missing from the bathroom floor in the bathroom.

Findings:

General: Based on Observation, there were four (4) tubes of diaper cream sitting out on a shelf in the One Year Old Room and two (2) tubes of diaper cream sitting out in the Infant Room. Additionally, the medication box was unlocked in the One Year Room and the Three Year Old Room. There were two (2) bottles of children's Advil and four (4) bottles of children's cough syrup in the medicine box in the One Year Old Room that were not labeled.

Also, the red formica table in the Preschool Room had several areas where the formica was missing as well. Additionally, in the One Year Old Room, there was one (1) high chair that was missing a safety strap.
