General: Based on observation in the school-age classroom, the surveyor found black residue, a cobweb, and a pitcher of water inside a cabinet underneath the handwashing sink. The surveyor observed a plastic bag containing water bottles inside of the cabinet.

General: Based on observation, in the children's restroom located downstairs, the surveyor found no liquid soap available.

General: Based on observation, the chain link fence attached to a gate, separating the preschool playground and basketball court, was bent, and not attached to the pole. Furthermore, the end of the pole was not secured to the bottom bar of the fence.

#### Findings:

General: Based on observation, the child-care center failed to get prior approval from the Division of Regulated Child Care (DRCC) before using a 2009 Ford E150 15-passenger van to transport children.

Review of documentation found that a 1998 Ford 15-passenger van has been the only vehicle approved by DRCC. An interview with the staff person in charge found that this vehicle is no longer in use. The staff person in charge started using the 2009 Ford in September 2021 to pick up children from Burlington and Goodridge Elementary Schools.

General: Based on review of documentation, an inspection of the Ford 2009 E150 15-passenger van was not completed by the transportation cabinet or it's designee.
