General: Based on observation, there was approximately a five (5) inch long hole in the wall under a sink located next to the trash receptacle in the girls' restroom near the library.

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

(3) A sink shall be:

- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;
- (f) Equipped with an easily cleanable waste receptacle; and
- (g) Immediately adjacent to a changing area used for infants and toddlers.

Findings:

General: Based on observation, water did not dispense from the cold water faucet when turned to the on position at a sink located next to the trash receptacle in the girls' restroom near the library. Also, water did not dispense from the cold water faucet when turned to the on position at a sink located next to a wall across from the last stall in the boys' restroom near the library.

General: Based on observation, weed block was raised above pea gravel in several places in the older children's outdoor play area.

(2) Indoor and outdoor equipment shall:

- (a) Be clean, safe, and in good repair;

- (c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint, poisonous material, and flaking or chalking paint; and
- (d) Be designed to guard against entrapment or situations that may cause strangulation.

Findings:

General: Based on observation, rust was on an approximately foot long area on three (3) stall walls in the girls' restroom in the cafeteria. Rust was on the chain links of eight (8) swings in the younger children's outdoor play area. Black stained marks were on the surface of a yellow tube and slide on a large apparatus in the older children's outdoor play area.

Findings:

General: Based on review of documentation, the center's written evacuation plan was not updated each year in accordance with KRS 199.895. The evacuation plan was last updated on 3/26/19.

1155 - Policies and Procedures

General: Based on review of documentation, the center did not conduct a fire drill in March 2021. Also, the center did not conduct a tornado drill and an earthquake drill during the first quarter of 2021.

(d) Information on the Kentucky Consumer Product Safety Program and the program's Web site as specified in KRS 199.897;

(e) A description of services provided by the child-care center, including:

1. Current rates for child care; and

2. Each service charged separately and in addition to the basic rate for child care;

(f) Minimum staff-to-child ratios and group size established in 922 KAR 2:120; and

(g) Daily planned program.

General: Based on observation, the Kentucky Consumer Product Safety Program and the program's website were not posted.
