A caregiver hired 11/15/18, did not complete any training hours between July 1 and the following June 30 of a subsequent year of employment.

- (7) The following shall be inaccessible to a child in care:
- (a) Toxic cleaning supplies, poisons, and insecticides;
- (b) Matches, cigarettes, lighters, and flammable liquids; and
- (c) Personal belongings and medications of staff.

Findings:

General: Based on observation, a large case of bleach was stored on a cart beside the girls restroom. These items were accessible to children and were labeled "Keep out of reach of children".

625 - Floors, Walls, Ceilings

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on observation, a hole with a four-inch diameter was in the wall behind the door in the small school-age room. A hole with a two- and one-half inch diameter was in the wall underneath the chalk board in the preschool room. A three feet section of chipped paint was on the wall beside chairs in the preschool room. In addition, several areas of chipped paint were on the wall in the small school-age room. Chipped paint was on wall behind the toilet in the girls' restroom.

General: Based on observation, an approximately twenty-three (23) feet long section of wire fence hung down toward the ground on the playground. A hole with a diameter of approximately twenty-four (24) inches was cut out of the chain link fence beside the building.

Findings:

General: Based on observation, rust was on the metal bars of a four (4) seat teeter-totter on the outdoor playground.

Several pieces of splintered wood and broken pieces of wood were on the floor of an iron school bus on the outdoor playground.

Two (2) smoke detectors continuously chirped in the hallway and in the school age room. Interview revealed the batteries did not work properly and needed to be replaced.

A white and brown substance covered the outside of the black trash can in the school-age room.

A large corner section was detached from the plastic cover of an activity table in the preschool room.
