Deficiency

The intent of this rule was not met:

Based on observation and interview, CCL found that the bathroom door could not be unlocked from the outside. Bathroom door knob should be replaced with one that does not lock or with one that can be unlocked from the outside if necessary. If a locking door knob is selected, the opening device must located within reach of the door.

Provider added a means to unlock the bathroom door and placed it within reach of the door.

- 121.6. Any outdoor play area must be maintained free from hazards such as wells, machinery and animal waste. If any part of the play area is adjacent to a busy roadway, drainage or irrigation ditch, stream, large holes, or other hazardous areas, the play area must be enclosed with a fence in good repair that is at least 4 feet high without any holes or spaces greater than 4 inches in diameter or natural barriers to restrict children from these areas.
 - a. Outdoor play areas shall be designed so that all parts are always visible and easily supervised by staff.

Deficiency

The intent of this rule was not met:

Based on observation and interview, CCL found that one side of the outdoor play area, adjacent to the neighboring property which could be hazardous to children, was without a fence. A fence, that is at least 4 feet high needs to be added to prevent children from leaving the outdoor play area.

Provider installed a fence between the outdoor play area and the adjacent property.
