Based on observation, CCL found that there were 4 children under the age of two in care with one caregiver. The second caregiver arrived at 11:35am. When only one caregiver is present, family child care numbers should be followed which includes only 3 children under the age of two.

**702.1.** Except for approved overlap care there shall be at least 2 caregivers caring for the children at all times when there are more than 6 children present at the home.

#### The intent of this rule was not met:

Based on observation, CCL found that there were 9 children in care with one caregiver. This was found during the provider's overlap time, however, with only one caregiver onsite, only 8 children should have been attending.
