As you know, one of the findings/concerns during the visit was 10 children in attendance with one caregiver. Even though the facility was in overlap time, only 8 children should have been onsite due to one staff member. One other item I neglected to mention, was that since there was only one caregiver onsite, only 3 children under 2 should have been at the facility. For the health, safety and care of the younger children, it is important that when only one caregiver is onsite, this is followed. If this is found in the future, a deficiency may be cited. Thank you for your cooperation in these matters.
