Based on interview, CCL found that caregivers did not supervise children at all times. Due to lack of supervision back in December, the facility was reported to CPS. Maly, a 2 years old boy, was found outside on the street after he was able to escape the building through the back door while one of the providers, Autumn Shay Kelly, was changing the diaper of another child. The gate that was protecting children from escaping was not locked at that moment.
